## **OPENING DATES OF 2024**

### **January 1 to January 31, 2024** Barbless hook

**Fish that can be caught :**

Carp, bream, roach, rudd and tench **NO-KILL**

Pike over 60 cm.

American crayfish

### **February 1 to March 1, 2024** Barbless hook

**Fish that can be caught :**

Carp, bream, roach, rudd and tench **NO-KILL**

American crayfish

### **March 2 to May 31, 2024**

**Only natural bait is allowed on barbless hooks**

**Fish that can be caught :**

Carp, bream, roach, rudd and tench **NO-KILL**

American crayfish

Perch, trout and brook salmon over 24cm \*

### **June 1 to December 31, 2024** Barbless hook

**Fish that can be caught :**

Carp, bream, roach, rudd, tench, minnow, dace, gudgeon, bleak **NO-KILL**

**NO-KILL** Shadow

Trout, perch and fountain salmon over 24cm

Pike over 60 cm \*

American crayfish, chub

Fishing is carried out one hour before the official sunrise time until one hour after the official sunset time

## **Before fishing you need :**

### **THE WALLON REGION LICENSE**

1-Permit A from the water's edge €12.39

2-Permit B for fishing in water and **crayfish** €37.18

**Free** youth license up to 15 years old only with certain restrictions

4-Tourist permit €25 equal to permit B and valid for 15 days

From now on, the fishing license for Lake Doyards or Lake Salm is no longer valid for fishing at the Tiennemesse pond.

## **ANY PERSON INTENDED TO FISH AT THE LAKE MUST HAVE THEIR FISHING LICENSE AND WALLON REGION LICENSE AND HAVE FOUNDED THE LAKE REGULATIONS**

The fishing license is compulsory from the age of 14 for children accompanied by an adult in possession of the company card. Mandatory for others regardless of age.

Children under 14 years of age fishing with a single hand line fitted with a **single barbless hook** are exempt from the Walloon region license on Saturdays, Sundays, legal public holidays and during school holidays provided that They are accompanied by an adult in possession of an RW license. For annual cards you can recover part of the sports club

membership fee from your mutual insurance company; you must request a form from your mutual insurance company and LA SALMIOTE will complete it.

## **REGULATION**

### **THE PROHIBITIONS AND OBLIGATIONS OF THE SALMIOTE.**

- 1: Night fishing is prohibited.
- 2: Wading (fishing with your feet in the water) is prohibited
- 3: Fishing from boats and all other boats is prohibited.
- 4: Fishing and baiting with blood, marrow and clutter (bloodworm) are prohibited
- 5 : Boats for baiting, laying lines and echo sounders are prohibited
- 6: **Barbed hooks are prohibited**
- 7 Recommended priming is limited to 5 liters of groundbait flour and 1 liter of maggots maximum.
- 8 For live pike fishing: only single hook without barbless
- 9 Any fish caught whose size is less than the regulated dimension must be returned to the water without being disgorged . **Obligation to cut the leader**
- 10 For white fishing, the landing mat is obligatory.
- 11 **The use of a dry cloth for No-Kill fishing is prohibited**
- 12 Obligation to use a suitable drain cleaner.
- 13 **The online fishing card must be accompanied by the catch control card also available on site. Without this card the fisherman must practice total NO-KILL: (prohibition on keeping fish)**

## **RW FISHING RULE**

- 1: The hamper is prohibited
- 2: Only two handlines can be used simultaneously by a fisherman who must be in direct proximity to them and able to constantly monitor them.

## **NUMBER OF AUTHORIZED SOCKETS**

**Daily pass:** limited to 5 fish maximum

**Pike and grayling NO-KILL**

Carp, bream, roach, rudd and tench **NO-KILL**

**Weekly menu :** 12 fish maximum

**Pike and grayling NO-KILL**

Carp, bream, roach, rudd and tench **NO-KILL**

**Annual menu:** 60 fish maximum with 2 pike maximum

**With 12 fish maximum over 7 consecutive calendar days**

Carp, bream, roach, rudd and tench **NO-KILL**

### **CONTROL AND SOCKET BOARD**

**The harvest control map is printed on the back of each permit. Must be completed by the fisherman after each retained catch before resuming fishing action.**

1-by the date from the first fish kept

2-by the first letter of the fish: ex **T** for trout , **B** for pike for **P** perch before starting to fish again

3-If the fisherman is no longer carrying his fish, he must surround the boxes of the fish concerned ex

**Any fisherman who has reached the number of authorized daily catches must stop fishing and put away his equipment so that he is no longer in a fishing attitude.**

**We draw your attention to the number of sockets authorized by the Walloon Region**

**The committee asks fishermen to only take fish for their personal consumption and reminds that it is prohibited to sell it.**

### **THE SURVEILLANCE**

Surveillance is ensured by the Society guard and the members of the committee upon presentation of their control card.

Any fisherman checked in fishing attitude on the course of the company 'LA SALMIOTE' must SPONTANEOUSLY present his fishing license and his identity card thus allowing the inspector to check whether or not the fisherman respects the regulations, namely being in possession of his fishing license which is STRICTLY PERSONAL.

If not, the fisherman must:

**Either stop fishing and leave the fishing route and pay compensation of 2 x the price of the week's license and the seizure of all catches**

Either pay the amount of the fishing card plus 2Euros to continue fishing

The fisherman must authorize the monitoring of his catch. If these are in a vehicle, he must authorize the inspection of it as well as all baskets, hampers, bags and pockets etc.

Fair play is essential in all situations (respect places and distances between fishermen)

### **S ANCTIONS:          non-exhaustive list**

IMPORTANT: The sanction provided for in violation of the regulations provides for the immediate withdrawal of the license for a minimum period of one week. After this period, the fishing license can be collected from the residence of the president (or his representative) **EXAMPLE of sanction - Fish not registered = one week of withdrawal** In the event of a repeat offense, the fishing license will be definitively withdrawn and a exclusion

- \* *Being in unauthorized fishing action "night fishing" for the first time : Warning with 1 week of withdrawal of the fishing license*
- \* *Being in unauthorized fishing action "night fishing" for the second time : Exclusion from society*
- \* *Deny control of sockets : Exclusion from society*
- \* *Having cut off the head in one or more sockets : Exclusion from society*
- \* *Be in excess of the number of authorized catches : Exclusion from society*
- \* *Unauthorized taking dead or kept alive : Exclusion from the company*
- \* *Take less than the legal dimension and preserved : Exclusion from the company*
- \* *Unauthorized boot first time: Warning with 1 week of card withdrawal*
- \* *Unauthorized priming second time : Exclusion from the company*
- \* *Fishing action during closed period for first time restocking : Warning and 1 week of withdrawal of the fishing license*
- \* *Fishing action during closed period for second time restocking: Exclusion from society*
- \* *Any lack of respect and/or correction towards the company or towards one of its representatives: Exclusion from the company*
- \* *Any fishing offense with a day or week card: Automatic resumption of the card*

In the event of a repeat offense: Exclusion from society

### **The committee reserves all rights on sanctions**

### **RESPECT THE PREMISES AND USE THE TRASH BIN & PARKING :**

The fisherman cannot park his vehicle on lawns, in front of homes or holiday apartments (Houyoux included). Use the main car parks: at the lake dike, around Fort-Doyards or in front of the cafeteria. \_

It is requested to respect PRM locations according to the regulations displayed for this purpose

### **CRAYFISH FISHING**

Only holders of a B license from the Walloon region can fish it.

Crayfish scales cannot exceed sixty centimeters

License B: 5 Scales Young license: 1 Scale

Animal offal is authorized as bait in the scale, it cannot be hung on the hook of a hand line

### **Dates are restocking. Please note fishing closes at 6 p.m.!**

1 , March 29, April 26, May 17, June 14, July 12, August 9, September 13,

FYI: in October or November: pike, perch, roach, carp, tench **no fishing closures.**
